By filling out and signing this application to show intent to ride in 2021 Hagyard Midsouth Team Challenge H.T. on an Area VIII Young Rider Select Team, you hereby agree to the following terms and conditions:

1. I agree to supply the Young Rider team coordinator with a copy of my proposed competition schedule leading up to 2021 Hagyard Midsouth Team Challenge H.T.
2. I understand that the Area VIII Young Rider selection committee will evaluate my performance at our Area VIII 2021 horse trials leading up to Team Challenge, my participations and performance at Area VIII YR clinics and camps, and that they may evaluate performance at events outside of Area VIII and/or seek input from my trainer or other professionals who have had the opportunity to observe my riding, horsemanship and attitude in working with and supporting other Young Riders.
3. I understand that as part of the Select Team that I will be expected to stable with and attend activities throughout the H.T. as a team.
4. I understand that to as part of the Select Team, we will have a team coach, but that I may still also use my personal coach at the H.T. as long as it does not interfere with team times.
5. I agree to sign the Code of Conduct and abide by it.
6. I understand that I am expected to arrive at the Kentucky Horse Park by 6 PM the evening prior to the first day of competition for my team.
7. I understand that I am expected to walk my Cross Country Course prior to the scheduled Team course walk.
8. I understand that at the H.T., I will be expected to fill a 2-hour volunteer window in show jumping with the members of my Select Team and other Young Riders, and attend all Young Rider educational activities, course walks and social events that do not conflict with my ride times.
9. If chosen for a Select Team, I agree to provide the team coordinator with a photo and short bio of myself and my horse and consent to Area VIII Young Rider's use of the same to promote those named to a Select Team.
10. If not chosen for a Select Team, I understand that I may still be named an alternate to join a Select Team if a later opening arises and the H.T. secretary permits the alternate to switch teams. If not chosen for a Select Team and even if I am named as an alternate, then I understand that I can still ride on an Area VIII Young Rider Team Challenge team either in a grouping selected by me or by the Young Rider team coordinator.

I have read the Area VIII Select Team Code of Conduct. I understand these documents and agree to be bound by them.

Select Teams will be named Area VIII YR Intermediate Select Team, Area VIII YR Preliminary Select Team, Area VIII YR Training Select Team, Area VIII YR Novice Select Team, and Area VIII YR Beginner Novice Select Team. Non-Select Teams can choose their own appropriate, non-offensive name which can include Area VIII YR, subject to Area VIII Young Rider approval.

ENTRY ON OPENING DAY IS IMPERATIVE

Entries must be complete or they will not be accepted by the Hagyard Team Challenge H.T. Organizing Committee. Area VIII Young Riders is not guaranteed any number of teams at the Event. We must get our entries in on opening day just like all other riders hoping to compete. Even then all of our teams may not be drawn to ride at the Event. We cannot hold spots for riders who do not have their completed entries in. This Event always fills very quickly and any scratches must be filled from the wait list in the order the entries were received.

FINANCIAL RESPONSIBILITIES

All riders are responsible for their own entry fees and stabling fees. Each Area VIII Team will have a tack stall the cost of which will be divided and paid equally by the riders on the Team. All riders are required to stable together as a Young Rider Team at the Event. Area VIII Young Riders will provide teamwear to our Select Teams that you will be able to keep, coaching, and goodies at our Area VIII Young Rider party at the H.T. Area VIII Young Riders may also provide an opportunity for its Area VIII Young Riders to purchase additional teamwear for the H.T.

AREA VIII YOUNG RIDERS ON NON-SELECT TEAMS

Area VIII Young Riders who failed to send in a timely Letter of Intent will still be eligible for a Non-Select Area VIII Young Rider Team. All Area VIII Young Riders are welcome to participate in the stabling, course walks, and various educational opportunities with the Select Teams. Non-Select Area VIII Young Riders may also form their own Area VIII Young Rider teams sending in their packets together and noting that they would like to be a team to Tammy Stevens. We strongly encourage all Area VIII Young Riders to take advantage of the wonderful opportunities that we will be offering in the Area VIII Young Rider barns by stabling with us and riding as part of the Area VIII Young Rider program.
